Critically endangered species in the country

60: SHRI PARIMAL NATHWANI:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the steps taken by Government to protect the critically endangered species in the country and the amount Government has spent in last three years on their protection; and
- (b) out of all these critically endangered species, which ones are present in Gujarat and Andhra Pradesh and the amount spent in this regard in these two States respectively?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

- (a)&(b) The important steps taken by the Government to ensure protection of critically endangered species are as under:
 - i. A network of Protected Areas (National parks, Sanctuaries, Conservation Reserves and Community Reserves) has been created in the country for conservation and protection of the wildlife.
 - ii. Legal protection has been provided to wild animals and plants against hunting and commercial exploitation under the provisions of the Wild Life (Protection) Act, 1972.
 - iii. The Wild Life (Protection) Act, 1972, has been amended from time to time and made more stringent. The punishment in cases of offences has been enhanced.
 - iv. Wildlife Crime Control Bureau coordinates with State/UTs and other enforcement agencies to gather intelligence about poaching and unlawful trade in wild animals and animal articles.
 - v. The local communities are involved in conservation measures through ecodevelopment activities, which help the forest department in protection of wildlife.
 - vi. The Ministry has launched the National wild life Action Plan (2017-31) for the conservation of wildlife through landscape level approach, including

conservation of critically endangered species.

vii. Financial assistance is provided to States/UTs for development of wildlife and management of habitat under the Centrally sponsored scheme 'Development of Wildlife Habitats'.

viii. Financial assistance is provided to States/UTs for species recovery programme of 22 identified critically endangered species viz Snow Leopard, Bustard including floricans, Dolphin, Hangul, Nilgiri Tahr, Marine Turtles, Dugong, Andaman Edible- nest Swiftlet, Wild Buffalo, Nicobar Megapode, Sangai, Vultures, Malabar Civet, Great Indian one-horned Rhinoceros, Asiatic Lion, Swamp deer, Jerdon's Courser, Batagur Baska, Clouded Leopard, Arabian Sea Humpback whale, Red Panda and Caracal, under the Centrally sponsored scheme 'Development of Wildlife Habitats'.

Among the 22 identified critically endangered species financially supported under the Centrally sponsored scheme 'Development of Wildlife Habitats ' Great Indian Bustard, Asiatic Lion, Marine Turtle , Dugong , Caracal and Dolphins are reported to be found in State of Gujarat and Marine Turtle, Jerdon's Courser, Great Indian Bustard , Dolphins are reported in the State Andhra Pradesh .

The detail of financial assistance provided to States/UTs including states of Gujarat and Andhra Pradesh for development of wildlife and its habitat including recovery programme of identified Critically endangered species during last three years under the Centrally sponsored scheme 'Development of Wildlife Habitats' is placed at **Annexure**
