Ramsar Site Wetlands

832. SHRI SURENDRA SINGH NAGAR:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether the wetlands have been identified as Ramsar sites in 2022;
- (b) if so, the details of such identified wetlands between the years 2022-2023;
- (c) the expected profit as a result of the said move;
- (d) the total number of wetlands designated as Ramsar Sites in India; and
- (e) the total area covered by wetlands in India?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

- (a) & (b) Yes, Sir. The Ministry of Environment, Forest and Climate Change (MoEF&CC) has designated 19 wetlands as Ramsar sites under the Ramsar Convention on Wetlands between the years 2022-23 as per the list given in **Annexure-1**.
- (c) The main advantages of designation of Ramsar sites are that it inter-alia encourages international cooperation, brings access to expert advice and latest information, presents an opportunity for a country to make its voice heard at the international and the Government level, provides an opportunity for wise use of wetlands and opportunity for getting international guidelines on various wetland conservation themes.
- (d) & (e). India has designated 75 Ramsar sites since 1981 covering an area of 13,26,678 hectares. As per the "National Wetland Decadal Change Atlas, 2017 published by Space Applications Centre- ISRO Ahmedabad, the total wetland area estimated is 15.98 million hectare (mha), including rivers and excluding paddy field areas, that is around 4.86% of the geographic area of the country.
