FINANCIAL ASSISTANCE FOR VETERAN ARTISTS SCHEME

Will the Minister of CULTURE be pleased to state:-

- (a) whether the Government worked out a special scheme named "Financial Assistance for Veteran Artists", for those who have contributed significantly in their specialised fields of performing arts and culture, but are facing financial difficulties due to old age and ill-health also
- (b) if so the details thereof, State wise along with funds sanctioned/spent till now?

- (a) Yes, Sir. The Ministry of Culture administers a Scheme by the name of "Scheme for Financial Assistance for Veteran Artists" for senior artists aged 60 years and above who have contributed significantly in their specialised fields of performing arts and culture, but are facing financial difficulties due to old age.
- (b)Under the scheme, financial assistance @6000/- per month is given to the selected artists aged 60 years and above whose annual income is not more than Rs. 48,000/- upon receipt of Digital Life Certificate once in a year and annual income certificate once in every 5 years. As regards state wise funds sanctioned, the 'Scheme for Financial Assistance for Veteran Artists' is a Central Sector Scheme under which financial assistance is provided to the beneficiaries directly and is not routed through the States/UTs. Funds released and number of artists supported in various States during the last three years and the current years under the said scheme is enclosed at Annexure.
