- (a): The Government of India is implementing the Central Sector Scheme for "Formation and Promotion of 10,000 Farmer Producer Organisations (FPOs)" scheme to form and promote 10,000 new FPOs. As on 30.06.2023, 452 FPOs are registered in Madhya Pradesh under the 10,000 FPOs scheme, out of which 121 FPOs are promoted by National Bank for Agriculture and Rural Development (NABARD) as Implementing Agency (IA).
- (b): As on 20.07.2023, 96 FPOs are linked with credit guarantee schemes in the State of Madhya Pradesh till date. The details are at Annexure.
