## Annexure referred in reply to Part (b to d) of Rajya Sabha Starred Question No. 112 for 13.12.2023

#### (i) Pre-Matric Scholarship for OBC, EBC and DNT Students

The objective of the Centrally Sponsored Scheme of Pre-Matric Scholarship for OBC, EBC and DNT students (who are not covered under SC, ST or OBC) is welfare and motivation to the children of these categories by providing financial assistance at pre matriculation or secondary stage.

#### (ii) Post-Matric Scholarship for OBC, EBC and DNT Students

The objective of the scheme is to provide financial assistance to the OBC, EBC and DNT students studying at post-matriculation or post-secondary stage to enable them to complete their education.

#### (iii) Top Class Education in School for OBC, EBC and DNT Students

The objective of the scheme is to provide financial assistance to the OBC, EBC and DNT students studying at post-matriculation or post-secondary stage to enable them to complete their education.

### (iv) Top Class Education in College for OBC, EBC and DNT Students

The objective of the scheme is to provide financial assistance to the OBC, EBC and DNT students studying at post-matriculation or post-secondary stage to enable them to complete their education in premium Institutes.

#### (v) Construction of Hostel for OBC Boys and Girls

The Scheme aims at providing hostel facilities to students belonging to socially and educationally backward classes, especially from rural areas, to enable them to pursue secondary and higher education. Priority will be given for the proposals for construction of hostels for undergraduate students vis-a-vis below under-graduate level.

#### (vi) National Fellowship for OBC Students:

The scheme is designed to provide a total number of 1000 Junior Research Fellowships per year to undertake advanced studies and research leading to M.Phil. /Ph.D. Degrees, who have qualified in the following tests:

- National Eligibility Test ) Junior Research Fellowship (NET-JRF) of UGC (for Humanities/Social Sciences) or
- UGC-Council of Scientific and Industrial Research (UGC-CSIR) NET-JRF Joint Test (for Sciences)

(vii) Dr. Ambedkar Central Sector Scheme of Interest Subsidy on Educational Loans for Overseas Studies for Other Backward Classes (OBCs) and Economically Backward Classes (EBCs):

This is a Central Sector Scheme to provide interest subsidy to the student belonging to the OBCs and EBCs on the interest payable for the period of moratorium for the Education Loans for overseas studies to pursue approved courses of studies abroad at Masters, M.Phil. and Ph.D. level.

(viii) Pradhan Mantri Daksha Aur Kushalta Sampann Hitgrahi (PM DAKSH) Scheme:-

The main objective of the Scheme is to provide high quality skills to candidates of age group 18-45 belonging to socially, educationally and economically marginalized sections of the society including OBCs through trailing institutes/partners.

#### (ix) Venture Capital Fund

The Venture Capital Fund (VCF-BC), a social sector initiative was launched in April, 2018 to promote entrepreneurship among the Backward Class in India. Initially a Capital of ₹ 145.03 crore, was provided for the purpose and is being supplemented every year. As per the guidelines of the scheme, preference is given on technology oriented innovative projects. The present corpus of VCF-BC is ₹ 145.03 crore with ₹ 139.58 Crore contributed by Government of India and ₹ 5.45 Crore contributed by IFCI Ltd. The total disbursements under the fund till 01.12.2023 are Rs. 28.63 crore benefitting 10 companies.

(x) Credit assistance to OBCs for income generating activities by National Backward Classes Finance and Development Corporation (NBCFDC):-

The Corporation promotes economic and developmental activities for the target population through concessional loans and skilling activities. The concessional lending is the major activity of the Corporation which is undertaken through State Channelizing Agencies (SCAs) and Banks (Channel Partners). The Corporation has an authorized share capital of Rs.1500 Crore against which the Ministry has so far released Rs.1499.40 Crore. The loan assets of the Corporation as on 30.11.2023 stood at Rs. 2083.78 Crore.
