- (a) Financial assistance is provided to the States/Union Territories for protection and conservation of Wildlife and its habitats. Details of the funds released under the Centrally Sponsored Scheme Development of Wildlife Habitats to the State/Union Territories Governments and corresponding utilization of the same in respect of protected areas including National Parks and sanctuaries during the last two years is placed as **Annexure**.
- (b) As per the provisions of Wild Life (Protection) Act, 1972, the State/Union Territory Governments are empowered to declare Protected Areas including National Parks in their respective States/UT. The Central Government is also empowered to declare National Parks in areas which are leased or transferred to the Central Government by the State Government. The National Wildlife Action Plan 2017-31 released by the Ministry envisages strengthening of protected area network in the country.
