**IMPLEMENTATION OF JAL JEEVAN MISSION**

101 # SHRI BIPLAB KUMAR DEB:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether a nationwide scheme has been implemented to provide drinking water through tap water connection to every households in the country;
- (b) the details of funds allocated and spent under Jal Jeevan Mission (JJM) during the last three years, the details thereof, year-wise and State-wise, including the State of Tripura; and
- (c) the details of connections provided to households under the scheme during the last three years, year-wise and State-wise, including district-wise details of connections for Tripura?

**ANSWER**

THE MINISTER OF STATE FOR JAL SHAKTI

(SHRI PRAHLAD SINGH PATEL)

(a) & (c) To enable every rural household in the country to have assured potable water through tap water connection, since Aug., 2019, Government of India in partnership with States is implementing Jal Jeevan Mission (JJM) - Har Ghar Jal.

At the time of announcement of Jal Jeevan Mission, 3.23 Crore (17%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 30.11.2023, around 10.47 Crore additional rural households have been provided with tap water connections. Thus, as on 30.11.2023, out of 19.24 Crore rural households in the country, more than 13.70 Crore (71%) households are reported to have tap water supply in their homes. State/ UT and year-wise details, *inter alia* including details for the State of Tripura, of tap water connections are at **Annex-I**. Further, the year-wise and district-wise details for the State of Tripura are at **Annex-II**.

(b) The year-wise and State/ UT-wise details of Central fund allocated, released and fund utilization reported by the States/ UTs under JJM in the last three years and current year, including those for the State of Tripura, are at **Annex-III**.
