ATAL BHUJAL YOJANA AND JJM IN RAJASTHAN

Will the Minister of JAL SHAKTI be pleased to state:

- (a) details of the works done by Government under Atal Bhujal Yojana and Jal Jeevan Mission (JJM) in the country, especially in Rajasthan, and the funds spent thereon, districtwise;
- (b) the details of the efforts being made by Government to accelerate the progress of work under the above schemes; and
- (c) district-wise details of tap connections provided under Jal Jeevan Mission in the State of Rajasthan?

ANSWER

(a) to (c) Government of India is implementing Atal BhujalYojana, a Central Sector Scheme with a total outlay of Rs. 6,000 crore in 8,213 water stressed Gram Panchayats (GPs) of 229 administrative Blocks/ Talukas in 80 districts of 7 States, viz., Haryana, Gujarat, Karnataka, Madhya Pradesh, Maharashtra, Rajasthan and Uttar Pradesh for a period of 5 years from 01.04.2020. The scheme aims at community led sustainable ground water management through convergence of activities.

The communities in all Gram Panchayats under Atal BhujalYojana, including in Rajasthan, have been mobilised through existing Village and Water Sanitation Committees and their capacities have been built up through focused Information, Education & Communication (IEC) and training programs in terms of ground water data collection and its importance in water budgeting for informed and decentralized decision making. All community led Water Security Plans (WSPs), including in Rajasthan, having details about water budget and proposed demand side interventions such as micro-irrigation, crop diversification, use of pipelines etc, and supply side interventions such as check dams, farm ponds, recharge shafts and other artificial recharge / water conservation structures, have been prepared. Implementation of the WSPs are being done in the field with active involvement of communities through convergence of various Central / State Government Schemes by concerned line departments.

District-wise fund release is not made, however, state wise release of funds under Atal BhujalYojana till date is at **Annexure I.**

Various steps viz. optimization of parameters as per the scheme objectives and standard operating procedures for data collection by the stakeholders, modifications in MIS with an aim to make it more user friendly, regular reviews at various levels along with field visits by National Program Monitoring Unit (NPMU) officers etc. have been taken for expeditious implementation of the scheme.

Since August 2019, Government of India is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal, in partnership with States/ UTs, to enable every rural household in the country to have assured potable water through tap connection.

At the time of announcement of Jal Jeevan Mission, 3.23 Crore (17%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 30.11.2023, around 10.45 Crore additional rural households have been provided with tap water connections under JJM. Thus, as on 30.11.2023, out of 19.24 Crore rural households in the country, around 13.69 Crore (71.16%) households are reported to have tap water supply in their homes. State/ UT-wise details of water tap connections provided so far are at **Annexure II.**

District-wise & project-wise fund allocations, schemes/ projects and details thereof are not made and maintained by this department. However, year-wise and State/ UT-wise details of Central share and fund utilization reported by the States/ UTs under Jal Jeevan Mission in 2019-20, 2020-21, 2021-22, 2022-23 & 2023-24 (as on 30.11.2023) are at **Annexure III**.

To achieve the goal of JJM in the whole country, with speed and scale Government of India is handholding the States, to expedite the implementation of the mission through number of steps inter alia, which includes joint discussions and finalization of annual action plan (AAP) of States/ UTs, regular review of implementation, workshops/ conferences/ webinars for capacity building and knowledge sharing, field visits by multi- disciplinary team to provide technical support, etc. A detailed Operational Guideline for the implementation of JJM; Margdarshika for Gram Panchayats & VWSCs to provide safe drinking water in rural households and Guidelines on a special campaign to provide piped water supply in anganwadi centres, ashramshalas and schools have been shared with States/ UTs to facilitate planning and implementation of Jal Jeevan Mission. For online monitoring, JJM–Integrated Management Information System (IMIS) and JJM–Dashboard has been put in place. Provision has also been made for transparent online financial management through Public Financial Management System (PFMS).

The district wise details of tap water connections provided under Jal Jeevan Mission in Rajasthan is at Annexure IV.
