**MODERNISATION OF POLICE FORCES**

**1176 SHRI RAJEEV SHUKLA:**

**Will the Minister of Home Affairs be pleased to state:**

- (a) whether Government is taking measures to modernise the Police Forces as well as Paramilitary Forces;**
- (b) if so, the details of progress made, force-wise;**
- (c) the benefits realised;**
- (d) the digital measures being implemented in this respect; and**
- (e) the proposed measures to be taken in this regard?**

**(a):**

**I. Police Forces :**

**Yes Sir. Modernisation of police forces is an ongoing and continuous process. 'Police' and 'Public Order' are State subjects as per the Seventh Schedule of the Constitution. It is the responsibility of the State Governments to develop the police infrastructure. However, the efforts of the States for equipping and modernizing of their police forces have been**

supplemented under the scheme of “Assistance to States & UTs for Modernization of Police (ASUMP)” [erstwhile scheme of Modernization of State Police Forces (MPF)].

**II. Paramilitary Forces :**

Modernization of Central Armed Police Forces (CAPFs) & Assam Rifles (AR) is also a continuous process. CAPFs & AR have been allotted sufficient funds under General Provisioning heads to maintain and upgrade their inventories as per their operational requirement.

(b) to (e):

**I. Police Forces :**

Under ASUMP scheme, the State Governments formulate their State Action Plans (SAPs) by including items as per their requirements and strategic priorities. These SAPs are considered by the High Powered Committee (HPC) in the Ministry and subsequently funds are released.

These items may include latest weaponry, training gadgets, communication equipment, forensic equipment, cyber policing equipment etc. The digital measures proposed by State Governments are also supported under ASUMP scheme.

**The budgetary allocations and releases to the State/UT Governments under the ASUMP scheme, during the last 3 years is at Annexure-I.**

**II. Paramilitary Forces :**

**Funds allotted to CAPFs & AR and expenditure incurred, under General Provisioning heads are as under :**

**Besides, the Government has approved a separate Scheme namely, Modernization Plan-IV for CAPFs, in continuation of Modernization Plan-III, with a total financial outlay of Rs. 1523 crore, till 31.03.2026. Force-wise Sanctioned Outlay under Modernization Plan-IV is at Annexure-III.**

**CAPFs & AR have procured the latest weapons, surveillance and communication equipment, specialized vehicles, protective gears etc. to enable them to perform important tasks such as guarding the borders and maintaining internal security. This plan bridges the gap between the**

**existing inventory/technology held by CAPFs & AR and the latest appropriate state of the art technology in view of the current security scenario across the country.**

**Under Modernization Plan-IV, besides other items, CAPFs & AR have also been authorized to procure various digital items as per their requirements.**
