(a) to (d) The focus of the Department of Social Justice and Empowerment (DoSJE) is on the welfare of the poorest households of the socially, educationally and economically marginalized sections of the society including Scheduled Castes (SCs), Other Backward Classes, Senior Citizens, Victims of Alcoholism and Substance Abuse, Transgender Persons, Beggars, De-notified and Nomadic Tribes (DNTs), Economically Backward Classes (EBCs) and Economically Weaker Section (EWS). This Department is implementing several Schemes for their welfare on Pan India basis which also includes Support to students from marginalized and EWS communities. The details of the schemes-wise fund allocation /utilized are in Annexure-I.

Further, the Ministry of Tribal Affairs is implementing below mentioned schemes to promote and encourage basic and higher education amongst ST population. The details of funds released under these schemes are in **Annexure-II**.

- i. Pre-Matric Scholarship Scheme for ST students (Class IX and X)
- ii. Post Matric Scholarship Scheme for ST students (Class XI and above)
- iii. National Fellowship Scheme for Higher Education for ST students.
