VOCATIONAL TRAINING IN TRIBAL AREAS

Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) whether Government is aware of the number of functioning vocational training centers in the year 2023-24, across the country;
- (b) if so, the details thereof, State-wise;
- (c) the details of the funds allocated to each state for VTC in the last three financial years; and
- (d) the details of the tribal girl beneficiaries for the year 2023-24, State-wise?

ANSWER

- (a) & (b) Yes, Sir. Under the Govt of India's Skill India Mission (SIM), the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through an extensive network of skill development centres/colleges/institutes etc. under various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsmen Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all sections of the society across the country. The SIM aims at enabling youth of India to get future ready & industry ready skills. The details of these schemes and training centers are as follows:
- i. The Craftsmen Training Scheme (CTS) is implemented through a network of Industrial Training Institutes (ITIs). Under this scheme, skill training is imparted in 152 National Skill Qualification Framework (NSQF) aligned courses (trades). These courses are designed to provide basic skills and knowledge in that trade, so as to prepare the trainees for wage employment and/ or self-employment. The course curriculum is updated regularly to incorporate the latest technological equipment and industry requirements for future job roles. At present, there are 15,016 ITIs established in the country, out of which 3,289 ITIs are Government and 11,727 ITIs are Private.

- **ii.** Craft Instructor Training Scheme (CITS) is implemented through a network of National Skill Training Institutes (NSTIs) and Institute of Training of Trainers (IToTs) across the country. In this scheme, comprehensive training is provided in both hands-on skills and training methodology to the instructor trainees to make them conversant with techniques of transferring hands-on skills and train skilled manpower for the industry. At present there are 33 National Skill Training Institutes (NSTIs) {19 NSTI (Women) & 14 NSTI (General)} and 121 Institute of Training of Trainers (IToTs) running across the country.
- **iii. Jan Shikshan Sansthan (JSS)** is a scheme under MSDE implemented through the agencies, to impart skill training to non-literates, neo-literates, persons with rudimentary level of education, and school dropouts up to 12th class in the age group of 15-45 years in rural areas and urban slums. At present, there are 288 JSSs functional across the country.
- **iv. Pradhan Mantri Kaushal Vikas Yojana (PMKVY)** is the flagship scheme of the MSDE with an objective to enable Indian youth to take up industry-relevant skill training that will help them in securing a better livelihood. PMKVY provides Short Term Training programs (STT) and also Recognition of Prior Learning (RPL) in industry relevant trades. Under PMKVY, at present there are 1,061 STT centres functioning in the country.
- v. Apprenticeship Training Scheme (ATS) regulated by Apprenticeship Act 1961 is also implemented by MSDE. Under Apprenticeship Act, all establishments having work force (regular and contract employees) of 30 or more are mandated to engage apprentices in a range from 2.5% to 15% of its workforce every year. Candidates engaged as apprentices by an industry gain classroom learning for a short period followed by hands-on training at the work place itself. MSDE has launched National Apprenticeship Promotion Scheme (NAPS), with an aim to promote apprenticeship training in the country by providing stipend support to the apprentices. At present, 27,067 establishments are engaging apprentice under Apprenticeship Act.

State wise list of vocational training centres functioning under above mentioned schemes is attached at *Annexure -I*.

- (c) MSDE has released Rs. 366.29 crores under JSS scheme, Rs. 969.72 crores under PMKVY during FY 2021-22 to FY 2023-24 and Rs. 114.78 crores under NAPS during FY 2020-21 to FY 2022-23. Apart from this, Rs. 217.62 crores have been released by MSDE to the State/ UTs under Skills Strengthening for Industrial value Enhancement (STRIVE) project to strengthen ITIs and for the promotion of Apprenticeship activities in the country during FY 2021-22 to FY 2023-24. State wise details of funds released by MSDE under various schemes is attached at *Annexure -II*.
- (d) MSDE is implementing PMKVY and JSS Scheme for providing short term 'Skill Development' training and NAPS, CTS and CITS for long term training, to the youth belonging to all sections of the society including tribal community. State wise enrolment of girls from Scheduled Tribes in vocational training centres functioning under various schemes implemented by MSDE for year 2023-24 is attached at *Annexure-III*.
