- (a) the number of Shakti Sadans being set up State-wise including Odisha;
- (b) whether it is a fact that there has been a decline in the expenditure under the scheme during the last five years; and
- (c) if so, the reasons therefor and if not, the details of the budgetary allocation towards the scheme in the last five years?

(a) to (c) The Shakti Sadan scheme under the overarching Mission Shakti, is a demand driven centrally sponsored scheme wherein States/UTs assess their requirement as per local needs and proposals are approved by the Programme Approval Board (PAB) after discussion with States/UTs. State/UT-wise details of functional Shakti Sadans, including Odisha (earlier Swadhar Greh and Ujjawala Homes) is placed at **Annexure–I.** 

The detail of Budget Estimate, Revised Estimate and funds released during the last five Financial Years period is given below:

The decline in the expenditure under the scheme was due to non-receipt of complete proposals from the States/UTs for fund release i.e. Utilization Certificate and Statement of Expenditure. Delay in opening of Single Nodal Agency (SNA) Account by the States/UTs also effected the less release of funds.
