Question
New industrial policy for the North East

1307. Shri Ajit Kumar Bhuyan:

Will the Minister of Development of North Eastern Region be pleased to state:

- (a) Whether it is a fact that the North East Industrial Development Scheme (NEIDS), 2017 expired on 31st March, 2022;
- (b) If so, the details thereof;
- (c) The State-wise, year-wise allocation, release and utilization of fund under NEIDS, 2017;
- (d) The details of submission of utilization certificates under NEIDS, 2017, State-wise;
- (e) By when Government will announce a new industrial policy exclusively for the North East;
- (f) The State-wise, year-wise allocation, release and utilization of funds under North East Industrial and Investment Promotion Policy (NEIPP), 2007; and
- (g) The State-wise submission of utilization certificates under NEIPP, 2007?

ANSWER

The Minister of State of the Ministry of Development of North Eastern Region

- (a) Yes, Sir.
- (b) The government launched North East Industrial Development Scheme (NEIDS) on 01.04.2017, which was notified on 12.04.2018. The scheme ended on 31.03.2022. NEIDS was launched to promote industrialization in the North Eastern States and boost income and employment generation.

(c) & (d) The incentives under NEIDS, 2017 are provided to the eligible industrial units on reimbursement basis, only after full implementation of the project and commencement of its commercial operations. Details of year-wise allocation and state-wise release of funds under NEIDS, 2017 are at **Annexure-I**.

(e) Formulation of a new policy involves various steps such as a series of stakeholder consultations, inter-ministerial consultations, Expenditure Finance Committee meeting and finally approval of Cabinet. Hence, it is not feasible to specify a particular date as to when a new industrial policy for North East will be announced.

(f) & (g) The subsidy under the North East Industrial and Investment Promotion Policy (NEIPP), 2007 were provided to the eligible industrial units on reimbursement basis. Details of year-wise and state-wise release of funds under NEIPP, 2007 are at **Annexure-II**.
