DEVELOPMENT OF TOURISM IN TAMIL NADU

1411. SHRI K.R.N. RAJESHKUMAR:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether the Ministry has proposed any schemes and financial assistance for the development of tourism in Tamil Nadu;
- (b) if so, the details thereof;
- (c) the number of projects being selected and considered for development;
- (d) the details of the financial assistance sanctioned/being sanctioned for each project; and
- (e) the details of the projects identified in Tamil Nadu?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (e): The Ministry of Tourism under the schemes of 'Swadesh Darshan', 'National Mission on Pilgrimage Rejuvenation and Spiritual Heritage Augmentation Drive (PRASHAD)' and 'Assistance to Central Agencies for Tourism Infrastructure Development' has provided financial assistance to State Government/Central Agencies for the development of tourism-related infrastructure in the State of Tamil Nadu.

The Ministry of Tourism has revamped its Swadesh Darshan Scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible destinations following a tourist & destination centric approach. Under SD2.0, 'Mamallapuram' & 'The Nilgiris' destinations have been identified for development in the State of Tamil Nadu.

Receiving proposals from the State Governments/UT Administrations for financial assistance for tourism projects is a continuous process. The proposals received are examined with reference to the prescribed guidelines and financial assistance is extended for such projects subject to fulfilment of the stipulated conditions, operational viability and availability of funds.

The details of projects sanctioned under the Swadesh Darshan 1.0, PRASHAD and Assistance to Central Agencies Schemes in the State of Tamil Nadu is given at **Annexure.**
