SPECIAL SCHEME FOR VALUE ADDITION OF AGRICULTURE PRODUCE

1448. DR. ANBUMANI RAMADOSS:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) whether Government has formulated any special scheme to add value to the agriculture produce to increase the income of farmers;
- (b) if so, the details thereof, State-wise;
- (c) whether Government has allocated special budgetary package for the above said schemes; and
- (d) if so, the details thereof for the last five years?

ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE
(SHRI ARJUN MUNDA)

(a) to (d): Ministry of Food Processing Industries (MoFPI) is implementing a central sector umbrella scheme Pradhan Mantri Kisan Sampada Yojana (PMKSY) since 2016-17 in order to aid value addition to the agriculture produce and to increase the income of farmers. Under its component schemes, it, inter alia, provides grants-in-aid to entrepreneurs for setting up of food processing/preservation industries with farm level infrastructure like primary processing facilities, collection centres etc. Government of India has also launched a centrally sponsored “PM Formalization of Micro food processing Enterprises (PMFME) Scheme” for a period of five years from 2020-21 to 2024-25 with an outlay of Rs. 10,000 Crore. The Scheme provides support to Self Help Groups (SHGs)/Farmer Producer Organizations (FPOs)/ Cooperatives for setting up/up-gradation of micro food processing units, Seed Capital to SHGs, Common Infrastructure, Marketing & Branding support etc. Assistance to value addition in

agricultural produce is also extended under various schemes being implemented by the Department of Agriculture and Farmers Welfare like National Bee and Honey Mission (NBHM), Farmer Producer Organizations (FPOs), Agriculture Infrastructure Fund (AIF), Mission for Integrated Development of Horticulture (MIDH) including the National Bamboo Mission (NBM), Mission Organic Value Chain Development for North East Region (MOVCDNER), Rashtriya Krishi Vikas Yojana (RKVY), Paramparagat Krishi Vikas Yojana (PKVY), Sub Mission on Agricultural Mechanization (SMAM) etc. State-wise allocation for centrally sponsored schemes concerned during the last 5 years are given in the Annexure.
