ACHIEVEMENTS UNDER MIDH

1456. SHRI NIRANJAN BISHI: SMT. SULATA DEO

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the achievements of Mission for Integrated Development of Horticulture (MIDH) in terms of increase in horticulture production, income levels of farmers, and improvements in market linkages, State-wise;
- (b) the details of state-specific strategies implemented under the scheme and their impact on the horticulture sector; and
- (c) whether Government plans to increase assistance under area expansion program taken up under MIDH, if not, the reasons therefor?

ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE

(SHRI ARJUN MUNDA)

(a) & (b): Government is implementing Mission for Integrated Development of Horticulture (MIDH) for the holistic development of horticulture in the country. Since inception of MIDH scheme i.e. from 2014-15, the horticulture production has increased from 280.98 million metric ton to 351.92 million metric ton as per 2022-23 second advance estimates resulting in increase of income of farmers.

To achieve the objectives of the MIDH scheme, the following strategies have been adopted throughout the country:

- Adopt an end-to-end holistic approach covering pre-production, production, postharvest management, processing and marketing to assure appropriate returns to growers/producers;
- Promote R&D technologies for cultivation, production, post-harvest management and processing with special focus on cold chain infrastructure for extending the shelf life of perishables;

- Improve productivity by way of quality through:
 - i. Diversification, from traditional crops to plantations, orchards, vineyards, flowers, vegetable gardens and bamboo plantations.
 - ii. Extension of appropriate technology to farmers for high-tech horticulture including protected cultivation and precision farming.
 - iii. Increase of acreage of orchards and plantation crops including bamboo and coconut, particularly in states where total area under horticulture is less than 50% of agricultural area.
- Improve post-harvest management, processing for value addition and marketing infrastructure.
- Adopt a coordinated approach and promote partnership, convergence and synergy among R&D, processing and marketing agencies in public as well as private sectors, at the national, regional, state and sub-state levels;
- Promote FPOs and their tie up with Market Aggregators (MAs) and Financial Institutions (FIs) to support and adequate returns to farmers.
- Support capacity-building and Human Resource Development at all levels, including, change in syllabus and curriculum of graduation courses at Colleges, Universities, ITIs, Polytechnics, as appropriate.

Following the above strategies, State-wise impact on the horticulture sector in terms of achievements under major components of MIDH is at Annexure.

(c) Under area expansion program of MIDH, assistance is provided at the rate of 25% to 40% of the prescribed maximum cost of cultivation for promotion of horticulture crops including fruits, vegetables, flowers, spices, aromatic and plantation crops. However, in case of North East and Himalayan States, TSP areas, Andaman & Nicobar and Lakshadweep Islands, higher rate of assistance at the rate of 50% of the cost is provided.
