DETAILS OF PMGKAY

1502 SHRI BINOY VISWAM:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

(a) the monthly expenditure incurred and grains distributed under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) since its launch, details of distribution, State-wise;

(b) the details of the procurement made for scheme and distribution targets met including the number of beneficiaries targeted and reached, State-wise and year-wise;

(c) the criteria considered by Government for identifying beneficiaries and reasons for variations in number of beneficiaries; and

(d) whether Government intends to do any study on targeting beneficiaries and the likely amount to be incurred in continuing the scheme for five years in the light of recent announcement of Government for continuing scheme for next five years?

A N S W E R MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

(a): In the wake of economic disruptions caused by the unprecedented out break of COVID-19 in the country, the Government in March 2020 had announced the distribution of additional free-of-cost foodgrains (Rice/Wheat) to about 80 Crore Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) beneficiaries at the scale of 5 Kg per person per month, over and above the regular monthly entitlements of foodgrains on their ration cards, so that the poor, needy and the vulnerable house holds/beneficiaries do not suffer on account of non-availability of adequate foodgrains during the times of economic crisis. PMGKAY has been implemented over a period of 28 months in 7 phases with an earmarked total financial outlay of approximately Rs. 3.91 Lakh Crore, and total food grains allocation of nearly 1118 LMT. Phase wise details of distribution is attached as **Annexure-I**.

Further, the Central Government, in order to remove the financial burden of the poor beneficiaries and to ensure nationwide uniformity and effective implementation of the PMGKAY had decided to provide food grains free of cost to 80 crore PMGKAY beneficiaries i.e. AAY households and PHH beneficiaries beginning from 1st January 2023 through the Targeted Public Distribution System (TPDS).The month-wise funds released to FCI and DCP States under PMGKAY from January-2023 to November-2023 is attached as **Annexure-II**. The details of foodgrains distributed under the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) is attached as **Annexure-III**.

(b): The procurement of wheat and paddy is undertaken by Government agencies for Central Pool which covers various welfare schemes of Government including PMGKAY. Scheme specific procurement of foodgrains is not done for central pool. The State-wise procurement of wheat and paddy (in terms of rice) in Central Pool during the last three years and current year (*as on 11.12.2023*) is at Annexure-IV(*for wheat*)&V (*for rice*) respectively. The details of State/UT-wise intended number of beneficiaries under the PMGKAY and the actual coverage is attached as Annexure-VI.

(c): The State/UT Governments have to identify, the beneficiaries within the ceiling determined for the States/UTs, the households to be covered under the Antyodaya Anna Yojana to the extent specified by the Central Government, in accordance with the guidelines applicable to the said scheme and the remaining households as priority households to be covered under the TPDS, in accordance with such guidelines evolved by the State Government itself. Thus, the criteria for identification of beneficiaries under Priority Households Category may vary from State to State.

(d): Keeping in view welfare of the beneficiaries of PMGKAY in terms of accessibility, affordability and availability of food grains for the poor and to maintain uniformity across the States, the Government has decided to continue to provide free food grains to about 81.35 Crore beneficiaries under the PMGKAY for a period of five years with effect from 1st January 2024, with an estimated financial outlay of Rs. 11.80 lakh Crore totally to be borne by Central Government.
