SUPPLY OF QUALITY WATER IN ADEQUATE QUANTITY UNDER JJM

1683. DR. SONAL MANSINGH:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the objective of the Jal Jeevan Mission (JJM) is to provide for provision of drinking water supply of prescribed quality in adequate quantity, on a regular and long-term basis, to every rural household in the country by 2024; and
- (b) the status of various States in the matter of providing water to every house under Jal Jeevan Mission?

(a) & (b) Government of India is committed to make provision for safe & potable tap water supply in adequate quantity, of prescribed quality and on a regular & long-term basis to all rural households in the country. Towards this end, the Government of India launched the Jal Jeevan Mission (JJM), to be implemented in partnership with states, in August 2019. Drinking Water is a state subject, and hence, the responsibility of planning, approval, implementation, operation, and maintenance of drinking water supply schemes, including those under the Jal Jeevan Mission, lies with State/UT Governments. The Government of India supports the States by providing technical and financial assistance.

Significant progress has been made in the country since the launch of Jal Jeevan Mission, towards enhancing access to tap water to rural households. At the start of Jal Jeevan Mission in August 2019, only 3.23 Crore (16.8%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 12.12.2023, around 10.57 Crore additional rural households have been provided with tap water connections under JJM. Thus, as on 12.12.2023, out of 19.24 Crore rural households in the country, more than 13.80 Crore (71.72%) households are reported to have tap water supply in their homes and the remaining 5.44 Crore are likely to be covered within the Mission Period.
