STEPS TO SUPPORT AND DEVELOP MSME UNITS IN TAMIL NADU

1705. SHRI R. GIRIRAJAN:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether it is a fact that thousands of MSME units were shut down after 2020 and if so, the details thereof;
- (b) the total MSME units registered in the country, State-wise, as on date;
- (c) whether Government has taken any effective steps to support and develop MSME units in Tamil Nadu in particular under GST regime;
- (d) if so, the details thereof and the total funds allocated in this regard; and
- (e) the various steps taken by Government to provide incentives and other encouragements to best performing MSME units in the country?

ANSWER

(a): As per Udyam Registration Portal, the total number of MSMEs which were shutdown during 01.07.2020 to 13.12.2023 are as follows:

(b): The total MSME units registered in the country, State-wise, as on 13.12.2023 is at Annexure.

(c) & (d): The Ministry of MSME, through its various schemes, programmes and policy initiatives, supports and develops MSMEs in the country, including the State of Tamil Nadu, under GST regime. The Ministry of MSME's schemes/programmes inter alia include Prime Minister's Employment Generation Programme (PMEGP), Credit Guarantee Scheme for Micro and Small Enterprises, Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Entrepreneurship Skill Development Programme (ESDP), Procurement and Marketing Support Scheme (PMSS), International Cooperation scheme, Tool Rooms, Technology Centre System Programme, National SC/ST Hub (NSSH), MSME Champions, etc. In addition, Ministry of MSME launched 'PM Vishwakarma' Scheme on 17.09.2023 to provide benefits to the artisans and craftspeople, working with their hands and tools, engaged in 18 trades covered under the Scheme.

The Ministry of MSME implements Central Sector Schemes. Funds are not allocated State-wise.

(e): The Ministry of MSME provides incentives and encouragement to the best performing MSME enterprises in the country through National Award Scheme wherein, the Ministry encourages innovative efforts of MSMEs and promotes their spirit in larger interest of qualitative development of MSMEs.

In addition to it, MSME Sustainable (ZED) Certification Scheme that is based on an assessment model which includes various parameters that encourage MSMEs to improve their processes and systems to enhance quality and also move towards sustainability. The MSMEs are benefitted through assessment on different parameters in Bronze, Silver and Gold certification levels.
