Performance of Ujjwala Scheme

1729 Shri Javed Ali Khan:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the details of number of beneficiaries under Ujjwala Scheme in the country as on date, State-wise;
- (b) the details of number of Ujjwala cylinders refilled during 2022 and 2023 till November, 2023, month-wise and State-wise; and
- (c) the details of number of Ujjwala cylinders which were not refilled during 2022 and 2023 till November, 2023, month-wise and State-wise?

ANSWER

(a) to (c): Pradhan Mantri Ujjwala Yojana (PMUY) was started in May, 2016 with an objective to provide access of clean cooking fuel to poor households across the country. Under PMUY, deposit free LPG connections are provided to adult women from poor households as per defined criteria. As on 30.09.2023, 9.59 Crore PMUY connections have been released in the country. State/UT-wise details of LPG connections released under PMUY are at **Annexure-I**.

State/UT-wise number of cylinder refills taken by Ujjwala beneficiaries during 2022 and 2023 (till November, 2023) are at **Annexure-II**. Month-wise number of cylinder refills taken by Ujjwala beneficiaries during 2022 and 2023 (till November, 2023) are at **Annexure-III**.

Per capita consumption of PMUY beneficiaries has increased from 3.01 Refills/annum (in terms of 14.2 Kg refill) during FY 2019-20, to 3.71 Refills/annum during FY 2022-23 & further to 3.8 refills in 2023-24 (till October 2023). Consumption of domestic LPG by households depends on multiple factors such as food habits, household size, cooking habits, price, availability of alternate fuels etc. During FY 2022-23, more than 87.5% PMUY beneficiaries took one or more refills.
