UPGRADATION OF HSC INTO HWC

1861 SHRI PARIMAL NATHWANI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Government is in the process of upgrading Health Sub-Centres (HSC) into Health and Wellness Centres (HWC), if so, the number of such HSCs upgraded in HWCs till date, State/UT-wise;
- (b) the human resources proposed at each HWC along with the number of human resources posted at such HWCs, State/UT-wise; and
- (c) whether there are any gaps in the human resources proposed at HWC and actual availability, if so, the details thereof and reasons therefor along with the initiatives taken by Government in this regard?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE

- (a): In February 2018, the Government of India announced establishment of 1,50,000 Ayushman Bharat Health and Wellness Centres (AB-HWCs) [now renamed as Ayushman Arogya Mandirs (AAMs)] across the country by December 2022. As updated by the States/UTs in AAM portal, a total of 1,62,991 Ayushman Arogya Mandirs have been established and operationalized till 30.11.2023. The existing Sub- Health Centres (SHC), Primary Health Centres (PHC) and Urban Primary Health Centres (UPHC) are transformed into AAMs to deliver Comprehensive Primary Health Care (CPHC) that includes preventive, promotive, curative, palliative and rehabilitative services which are universal, free, and closer to the community. The State/UT-wise number of AAMs operationalized including Sub-Health Centres is attached at **Annexure-I**.
- (b) & (c): For SHC-AAM, operational guidelines for Ayushman Bharat Comprehensive Primary Health Care through Health and Wellness Centres provides for Multipurpose worker (Male and Female) led by Mid level Health provider along ASHAs in the catchment area. For PHC-AAM, the norms provide for Medical Officer, Staff Nurses and Lab technician. No. of human resource posted at such AAM is attached at **Annexure-II**.

Under National Health Mission (NHM), Government of India provides financial and technical support to States/UTs to strengthen their healthcare systems including support for recruitment of doctors and other health human resources on contractual basis, based on the requirements posed by them in their Programme Implementation Plans (PIPs) within their overall resource envelope.
