STATUS OF IMPLEMENTATION OF THE HIV AND AIDS (PREVENTION & CONTROL) ACT, 2017

1872. SMT. SANGEETA YADAV:

Will the Minister of **HEALTH & FAMILY WELFARE** be pleased to state:

- (a) whether it is a fact that Government has implemented the HIV and AIDS (Prevention & Control) Act, 2017;
- (b) if so, the details thereof and the progress made in its enforcement and monitoring;
- (c) the measures taken by Government to provide care, support and treatment to HIV affected women patients and children of affected parents in terms of nutrition, education, and social protection; and
- (d) the budgetary allocation and expenditure for the National AIDS Control Programme(NACP) and the various schemes and interventions under it for the welfare of HIV affected women and children in the last five years, year-wise and State-wise?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH & FAMILY WELFARE (PROF. S. P. SINGH BAGHEL)

(a) & (b): The HIV and AIDS (Prevention & Control) Act was notified by the Government of India on 21st April 2017 and it came into effect from 10th September, 2018 with the objective to prevent and control the spread of HIV and AIDS and for reinforcing the legal and human rights of persons infected with and affected by HIV and AIDS.

After coming into force, progress has been made thereafter. The State Governments have notified their State Specific Rules to carry out the provisions of this Act. A workplace policy namely the 'HIV and AIDS Policy for Establishments 2022' has been formulated under section 12 of the Act to mitigate issues surrounding HIV and AIDS in a workplace setting. Nine Central Government

Guidelines on subject matters of Care, Support and Treatment of Children Infected with HIV or AIDS, Anti Retro Viral therapy and Opportunistic infections management, Universal Precautions and Post Exposure Prophylaxis, Testing, Informed consent, Risk reduction strategies, HIV related Information, Education and Communication before marriage, HIV related services for person in care or custody of state and confidentiality of data of protected person have been notified. The grievance redressal mechanism provided in the Act has been established by appointed/designated Ombudsman and Complaints Officer in the States to address complaints relating to violations of the Act.

(c) & (d): Government of India has taken various steps to provide free life-long, high quality antiretroviral (ARV) medicines free of cost to all people living with HIV (including women and Children) from treatment facilities across the country through the National AIDS and STD Control Programme (NACP).

State Governments have also taken measures to provide various exclusive and inclusive schemes in terms of nutrition, education and social protection benefits to people living with HIV including women and children infected and affected by HIV. The State wise list of schemes is attached as Annexure 1 and the budgetary allocation and expenditure for National AIDS Control Programme(NACP) in the last five years is attached as Annexure 2.
