**COAL IMPORTED BY POWER GENERATION COMPANIES IN ANDHRA PRADESH**

- (a) the details of the number of power generation company located in the State of Andhra Pradesh;
- (b) the details of coal imported by these power generation companies in the State of Andhra Pradesh since May, 2019;
- (c) whether any violation of rules/norms in import of coal by these companies have been reported; and
- (d) if so, the details thereof and the action taken against those violating companies?

**(a):** There are 19 power generation companies in the State of Andhra Pradesh. The details of power generation companies are given at **Annexure-I**.

**(b):** The details of coal imported by the coal based power plants located in the State of Andhra Pradesh during May, 2019 to October, 2023 are given at **Annexure-II**.

**(c) & (d):** Coal, whether domestic or imported, is procured by Thermal Power companies separately and as per their requirements. Coal is under open general license (OGL) and thermal power plant/ generators have been regularly importing coal as per their preference (imported coal has higher GCV and therefore of better quality) and needs based on their commercial prudence.

No violation of rules/norms in import of coal by power generation companies in the State of Andhra Pradesh has been reported.
