STATE'S SHARE IN LAND ACQUISITION OF NH

2008. SHRI ELAMARAM KAREEM:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

- (a) the details of amount spent by State Governments and NHAI for land acquisition and related activities for the development of National Highways for last five years, State-wise details;
- (b) whether there are States that have spent 25 per cent or more share for land acquisition for NH development; and
- (c) whether Government will assist the States to reduce the financial burden connected with the NH development, if so, the details thereof?

ANSWER

(a) to (c) Ministry is primarily responsible for development of National Highways (NHs) in India. Generally, entire cost of execution of NH projects is borne by Central Government. In some cases, State Governments share part of the some cost component of the projects.

State / Union Territory (UT) – wise details of amount spent by State Governments on NHs Projects for Land Acquisition (LA) and related activities, including the States that have spent 25 per cent or more share for LA, are at Annexure-I.
