#### **Targets fixed for WDC-PMKSY**

#### 2019. Shri Mukul Balkrishna Wasnik:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether it is a fact that Government has decided to develop 4.95 million hectares of rainfed and degraded lands under WDC-PMKSY 2.0 by the year 2025-26; and
- (b) if so, the details of amount spent achievement made under this scheme so far, yearwise and district-wise; and
- (c) the details of the steps being taken/planned to achieve targets fixed for WDC-PMKSY2.0 within the target year of 2025-26?

#### ANSWER

#### MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI FAGGAN SINGH KULASTE)

(a) to (c): Yes,

New generation of watershed scheme i.e. Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0) for the development of 4.95 million hectare of rainfed/ degraded areas has been approved by the Government on 15.12.2021 with an outlay of Rs.8134.00 crore (Central Share) for a period of 2021-22 to 2025-26.

Under WDC-PMKSY 2.0, total 1149 watershed projects covering an area of 50.55 lakh ha at a total project cost of Rs.12388.58 crore (Central share of Rs.8073.85 crore) have been sanctioned in the country and as on 13.12.2023, an amount of Rs.2912.93 crore Central share of fund has been released to States/UTs

Year-wise details of Central share funds released and physical achievement made under WDC-PMKSY 2.0 is given at **Annexure I and II.** *Inter se* distribution of funds (Central share plus State share) amongst the Districts/ projects in a particular State is undertaken at the State level by the respective States/UTs.

To achieve the targets, Department of Land Resources is regularly reviewing the progress of implementation of the scheme with the States /UTs. D.O. letters to Chief Secretaries / Secretaries of States are issued from time to time. Regional Review Meetings, Video Conferences and Field visits to States by Senior Officers of Department are undertaken on regular basis. Besides these, to review the implementation of WDC-PMKSY 2.0, Department had organized a National Level meeting of State / UT Governments under the chairmanship of Secretary, DoLR on 10.6.2022 to review the implementation of programme and a National Watershed Conference on 14<sup>th</sup> July, 2022 at Vigyan Bhawan, New Delhi. Regional Review Meetings to review the implementation of scheme in States under the Chairmanship of Secretary/Additional Secretary, DoLR have also been organized.

Further, in order to have a comprehensive concurrent monitoring of the programme / schemes implemented by the Department, Zonal Monitoring Committees have been constituted headed by Additional Secretary / Joint Secretary level officer, in the Department for undertaking field visits to cover all States and UTs.
