**IMPLEMENTATION OF ALL HEALTH SCHEMES IN KERALA**

Will the **MINISTER OF HEALTH AND FAMILY WELFARE** be pleased to state:

- ( a ) the number of beneficiaries of Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), Pradhan Mantri Matru Vandana Yojana, Surakshit Matritva Abhiyan, Health and Wellness Center and Janani Suraksha Yojana in the State of Kerala, district-wise;
- ( b ) whether Government of Kerala made any changes in the nature of AB-PMJAY;
- ( c ) If so, the details thereof;
- ( d ) the difficulties faced in implementing all schemes, including AB-PMJAY as a result of these changes; and
- ( e ) the positive results in all the health statistics of Kerala with the efforts of Government since 2018?

(a) to (e) The number of beneficiaries of Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), Pradhan Mantri Matru Vandana Yojana (PMMVY), Pradhan Mantri Surakshit Matritva Abhiyan(PMSMA), Health and Wellness Center and Janani Suraksha Yojana (JSY) in the State of Kerala, district-wise are placed at **Annexure-I, II, III, IV and V** respectively.

In the State of Kerala, AB PM-JAY – KASP (Karunya Arogya Suraksha Padhathi) is implemented as per the framework of Ayushman Bharat PM-JAY scheme. The uptake of the AB PM-JAY is the highest in the State of Kerala with respect to hospitalization per lakh beneficiaries. The institutional delivery in Kerala is 99.8% as per NFHS-5( 2019-21).

## Annexure-I

A total of 41.70 Lakh families are eligible for healthcare benefits under the converged scheme, of which 23.97 Lakh families are supported by Central and State Governments and additional 17.73 Lakh families are supported exclusively by the State Government.
