National Co-operative Database

326. Dr. Dharmasthala Veerendra Heggade:

Will the Minister of COOPERATION be pleased to state:

- (a) whether Government is developing a comprehensive National Co-operative Database in a phased manner and if so, the details thereof;
- (b) whether Government plans for mapping of about 2.64 lakh Primary Cooperative Societies in the country, if so, the details thereof; and
- (c) the details of State-wise Cooperative Societies in the country as on 30/9/2023, as per the Statistical Profile of Indian Co-operative Movement-2018 published by National Co-operative Union of India?

ANSWER

THE MINISTER OF COOPERATION (SHRI AMIT SHAH)

(a) and (b): Yes Sir, in order to provide a real time single point access to updated information about cooperative societies registered under various Acts and working under various sectors and to plan, monitor and channelize resources of all the Cooperatives, thereby boosting the Cooperative Movement in the country, a comprehensive National Cooperative Database is being developed under the Ministry of Cooperation, Government of India.

Keeping in view the diverse nature and size of cooperative sector, it was decided to create the database by collection of data in a three phased manner.

- i. Phase-I of National Cooperative Database: Under Phase-I, the mapping of about 2.64 lakh primary cooperative societies of three sectors i.e. Primary Agriculture Credit Societies (PACS), Dairy and Fisheries was completed in February, 2023. The number of societies mapped in Phase-I under these sectors were 1,03,448 (PACS), 25,528 (Dairy) and 1,41,320 (Fisheries) respectively.
- ii. Phase-II of National Cooperative Database: Under Phase-II, Mapping of National Cooperative Societies/Federations along with their General Body Members was completed. Further, their downward linkages with State Federations, District Unions and Primary Cooperative were also established. The data related to State Cooperative Banks (StCBs), District Central Cooperative Banks (DCCBs), Urban Cooperative Banks (UCBs), State Cooperative Agriculture and Rural Development Banks (SCARDBs), Primary Cooperative Agriculture and Rural Development Banks

(PCARDBs), Sugar Cooperative Mills, State Federations, District Unions and MSCS were collected directly from cooperative society or through their National/State Federations.

- iii. Phase-III of National Cooperative Database: Under Phase-III, Ministry of Cooperation initiated the process of extending the National Cooperative Database to remaining more than 5 lakh cooperative societies working in all other sectors in May, 2023, through the Office of RCSs of State/UTs. Almost all States/UTs, except Kerala & Manipur, completed (97%) data entries under National Cooperative Database.
- (c): As per the data published by National Cooperative Union of India (NCUI) in its Indian Cooperative Movement- a Statistical Profile-2018, the details of the State-wise cooperatives societies data is placed in Annexure-"A".
