EXPENDITURE ON PRISONERS

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether it is a fact that the number of prisons at national level in the country have dropped in the last five years;

(b) if so, the details thereof, State-wise; and

(c) the details of the expenditure per prisoner incurred thereof, State-wise?

(a) and (b): The National Crime Records Bureau (NCRB) compiles prison statistics reported to it by the States and Union Territories (UTs) and publishes the same in its annual publication "Prison Statistics India". The latest published report is of the year 2022. State/UT-wise details of number of prisons in the country as on 31st December of 2018, 2019, 2020,2021 and 2022 are given in Annexure-I. The data on the number of prisons in the country in the last five years does not reveal any consistent trend of decrease in numbers.

(c): State/UT-wise details of expenses incurred on inmates by the States/UTs as reported to NCRB during the financial year 2022-23 are given in Annexure-II.
