CONSTRUCTION OF ROADS UNDER CRIF IN KARNATAKA

412. SHRI IRANNA KADADI:

Will the Minister of ROAD TRANSPORT AND HIGHWAYS be pleased to state:

(a) the details of funds mobilized and spent by Government under Central Road and Infrastructure

Fund (CRIF) scheme during the last three years and the current year, State/UT-wise;

(b) the number of roads identified for development under CRIF scheme in the country including Karnataka, district-wise;

(c) the details of the roads identified and the construction work started on the recommendations of the State Government of Karnataka and the time by which all these works are likely to be completed;

(d) whether inspection regarding implementation of CRIF scheme has been conducted; and

(e) if so, the details and outcome thereof?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

(a) The Ministry allocates funds for State Governments / Union Territories (UTs) for development and maintenance of State Roads under the Central Road & Infrastructure Fund (CRIF) Scheme as per the provisions of the Central Road and Infrastructure Fund (CRIF) Act, 2000 amended by the Finance Act, 2019.

State / UT - wise details of accrual of funds and the funds released for development and maintenance of State roads under CRIF Scheme during the last three years and the current year are placed at Annexure-I.

(b) State / UT – wise details of proposals for State Road projects received and finalized under CRIF Scheme during the last three years and the current year, including for the State of Karnataka, are placed at Annexure-II. The proposals are finalized State / UT - wise and not district-wise.

(c) Thirty-six State Road projects, including two bridges, in a length of about 241 km amounting to Rs. 663 Crore, are under implementation under CRIF Scheme in the State of Karnataka, with scheduled date of completion in a phased manner by September, 2024.

(d) and (e) Based on the section 7A and 11 of CRIF Act, 2000, the Ministry finalised the criteria for allocation of funds for development and maintenance of State Roads under CRIF Scheme in consultation with the Ministry of Finance and circulated the same to all State Governments and UTs in January, 2020 and amendments were issued in April, 2022.

The criteria inter-alia provides for inspection of works under the scheme as under:-

i. Project monitoring and quality control of works to be done at regular intervals.

ii. Quality monitoring system at State / UT level to consist of experts and supporting staff appointed by State Govt. / UT including State Quality Monitor.

iii. Quality monitoring system at State / UT level to devise a Quality Assurance System delineating requirement of quality, responsibility of officers and contractors, conduct independent tests, examine Quality Assurance documentation, responsibility of training PWD staff and recommending laboratory and field testing facilities.

iv. Inspection of works by civil engineer(s) having degree in civil engineering and 10 years' experience / Inspection of works by an independent impartial agency/ firm.
