Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of the performance of the Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) in the country since its implementation; and
- (b) the State-wise growth in funds utilisation of PMAY-G in last five years, year-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

- (a) In order to achieve the target of "Housing for All" in rural areas, the Ministry of Rural Development is implementing Pradhan MantriAwaasYojana- Gramin (PMAY-G) with effect from 1st April 2016 to provide assistance to eligible rural households with an overall target to construct 2.95 crore pucca houses with basic amenities by March, 2024. The total target of 2.95 crore houses has been allocated to the States/UTs across the country, out of which more than 2.94 crore houses have been sanctioned to beneficiaries by the States/UTs and 2.50 crore houses have already been completed as of 30.11.2023.
- (b) The State-wise details of fund utilized by the States under PMAY-G from 2018-19 to 2022-23 is given in **Annexure**.
