SKILL DEVELOPMENT PROGRAMMES IN UTTARAKHAND

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be please to state:

- (a) whether Government is planning to promote skill development programs in the State of Uttarakhand;
- (b) if so, the details of steps taken during the last three years; and
- (c) the details of current status of the centers established, and trained persons in Uttarakhand under the said programs, district-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

(a to c) The Skill India Mission (SIM) aims at skilling, re-skilling and up-skilling to ensure that young Indians are prepared for the large number of opportunities coming up as the economy expands and India moves to become the third largest economy in the world. SIM is aimed at giving access to youth in India to get future-ready, Industry-ready skills.

Under SIM, the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country including Uttarakhand. The brief of these schemes is as under:

Pradhan Mantri Kaushal Vikas Yojana (PMKVY): PMKVY Scheme is for imparting skill development training through Short-Term Training (STT) and upskilling through Recognition of Prior Learning (RPL) to youth across the country.

Jan Shikshan Sansthan (JSS) Scheme: The main target of the JSS is to impart vocational skills to the non-literates, neo-literates, and the persons having rudimentary level of education up to 8th standard and school dropouts up to 12th standard in the age group of 15-45 years. Priority is given to Women and candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Minorities. The objective of the scheme is to increase household income by promoting self/wage employment through Skill Development training.

National Apprenticeship Promotion Scheme (NAPS): This Scheme is for promoting apprenticeship training and increasing the engagement of apprentices by providing financial support for payment of stipend to apprentices. Training consists of Basic Training and On-the-Job Training / Practical Training at workplace in the industry.

Craftsmen Training Scheme (CTS): This scheme is for providing long-term training through Industrial Training Institutes (ITIs) across the country. The ITIs offer a range of vocational/skill training courses covering a large number of economic sectors with an objective to provide skilled workforce to the industry as well as self-employment of youth.

The district-wise number of candidates trained / enrolled under PMKVY, JSS, NAPS and CTS in the State of Uttarakhand during last 3 years (2020-21,2021-22 and 2022-23) is at **Annexure-I** and district-wise detail of centres under these schemes is at **Annexure-II**.
