442. #Shri Rajendra Gehlot:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the increase in the number of women entrepreneurs in the country, State-wise, particularly for the State of Rajasthan,;
- (b) whether Government proposes to launch any new schemes or programmes to promote women entrepreneurs in the country, if so, the State-wise details thereof, including the State of Rajasthan; and
- (c) whether Government is launching any special programme to promote entrepreneurship among rural women in the country, and if so, the details thereof?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI RAJEEV CHANDRASEKHAR)

(a) to (c) Under the Government of India's Skill India Mission (SIM), the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society, including women. The SIM aims at enabling youth of India to get future ready & industry ready skills.

MSDE has also taken various initiatives to promote women entrepreneurship in urban as well as rural areas across the country, including the State of Rajasthan through its Autonomous Institutions namely, National Institute for Entrepreneurship and Small Business Development (NIESBUD), Noida and Indian Institute of Entrepreneurship (IIE), Guwahati. Further, for Skill Training of Women, 311 ITIs exclusively for women are also functional. In addition, there are 19 National Skill Training Institutes (NSTIs) for women which organise skill training programmes under Craftsmen Training Scheme (CTS) and Training of Trainers under Crafts Instructor Training Scheme (CITS).

The details of the various initiatives/programmes undertaken by MSDE for development of Women Entrepreneurs are as under:

(i) Strengthening Entrepreneurial Climate through Capacity Building, Incubation Support, Mentoring and Handholding sanctioned under SANKALP Scheme

NIESBUD is implementing the project for strengthening the entrepreneurship ecosystem to different sections of the society including marginalized population with the support of SANKALP Programme of the Ministry of Skill Development and Entrepreneurship (MSDE). The number of state wise women beneficiaries covered in the project through capacity building interventions is as under:

(v) Pilot Project for Entrepreneurship Development Program

NIESBUD has implemented a Pilot Project for Entrepreneurship Development Program in 10 States sponsored by the Ministry of Skill Development and Entrepreneurship which aims at creating, fostering and promoting the spirit of entrepreneurship among the target groups through Entrepreneurship Development Programme, Mentoring and Handholding support. The number of women participants trained in the project is as under:

(vi) **Economic Empowerment of Women Entrepreneurs and Start-ups by Women (WEE)** project was supported by 'Deutsche Gesellschaft für Internationale Zusammenarbeit' (GIZ) on behalf of the German Federal Ministry for Economic Cooperation and Development (BMZ) in partnership with the MSDE to improve the framework conditions for women-led enterprises in India. WEE project was launched by the MSDE in 2018, initially for duration of 3 years (2018-2021) which was further extended for one year to July, 2022. The project aimed to pilot incubation and acceleration programmes for women micro entrepreneurs, enabling them to start new businesses and scale up existing enterprises in the States of Maharashtra, Rajasthan, Telangana, Uttar Pradesh, and Eight North Eastern States of the Country. Under the title of 'Her & Now', the WEE project had carried out a film and media campaign to share the stories of successful Women Entrepreneurs and to foster a positive mindset change on gender roles and norms in the society. Over 908 Women Entrepreneurs were supported under the project under both incubation and acceleration support programmes. The State-wise/region-wise number of women entrepreneurs supported under the project under both incubation and acceleration support programmes from 2018 to 2022 is as under:

The details of the various initiatives taken by Ministries/Departments of the Government to promote entrepreneurship among women in the country are as under:

(i) **Ministry of Rural Development (MoRD)** is implementing Rural Self Employment Training Institutes (RSETIs) welfare schemes in the field of skill development and Entrepreneurship for rural poor youth under the National Rural Livelihoods Mission (NRLM) for gainful employment and to eradicate poverty in the country. Under the RSETI scheme, 591 RSETIs are functioning in 577 districts in 33 States and UTs across the country. These RSETIs are extending Skill and Entrepreneurship training to rural unemployed youth by commencing their own micro enterprises. The state wise details of total unemployed women trained and settled are given in **Annexure-I**.

At present, out of the 591 RSETI functioning in 577 districts across the country, 35 RSETIs are functioning in the State of Rajasthan. MoRD has taken the initiative to expand the RSETIs scheme by opening new RSETIs in 111 uncovered districts of which 15 will be in the state of Rajasthan. The State-wise number of new RSETIs to be opened in the uncovered districts is provided in **Annexure-II**.

(ii) **Ministry of Micro, Small and Medium Enterprises (MSME)**, through Khadi and Village Industries Commission (KVIC), is implementing Prime Minister's Employment Generation Programme (PMEGP) for assisting entrepreneurs in setting up of new units in the non-farm sector. It aims to provide employment opportunities to traditional artisans/ rural and urban unemployed youth at their doorstep. Under PMEGP,

General Category beneficiaries can avail of Margin Money (MM) subsidy of 25% of the project cost in rural areas and 15% in urban areas. For beneficiaries belonging to Special Categories such as Scheduled Castes, Scheduled Tribes, Other Backward Classes (OBCs), Minorities, Women, Ex-servicemen, Physically Handicapped, Transgenders, beneficiaries belonging to Northeastern Region, Hill and Border areas, and Aspirational Districts, the Margin Money subsidy is 35% in rural areas and 25% in urban area. The maximum cost of project is Rs. 50 lakhs in the manufacturing sector and Rs. 20 lakhs in the service sector. Also, **own contribution of beneficiaries under Special Category including women is 05%** in comparison to 10% for General Category beneficiaries. Since 2018-19, existing PMEGP/ Rural Employment Generation Programme (REGP)/MUDRA enterprises are also supported based on past good performances with 2nd loan for upgradation and expansion. Under 2nd Loan, maximum project cost admissible for Margin Money (MM) subsidy under Manufacturing sector is Rs. 1.00 crore and for Service sector is Rs. 25 Lakhs. Eligible subsidy on 2nd loan for all categories is 15% of project cost (20% for NER & Hill States). The details of women owned enterprises assisted under PMEGP during last 3 years and current year State/UT wise including the State of Rajasthan is at **Annexure-III**.
