WELFARE SCHEMES FOR TRIBALS

467 SHRI PARIMAL NATHWANI:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) the details of schemes for Tribals being run in Andhra Pradesh and Gujarat;
- (b) the details of Non-Governmental Organizations which are implementing the said schemes;
- (c) the details of amount allocated and spent by the said organizations in the last three years, scheme-wise and organization-wise;
- (d) whether Government is aware that the allocated amount has been diverted for other purposes;
- (e) if so, the details thereof; and
- (f) the details of step being taken by Government to keep a check on the same?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a), (b) & (c): Ministry of Tribal Affairs is administering the scheme of "Grant in Aid to Voluntary Organizations working for the welfare of STs" in pan-India basis including the State of Andhra Pradesh & Gujarat. The prime objective of the scheme is to enhance the reach of welfare schemes of the Government and fill gaps in the sectors such as education, health & livelihood through the efforts of voluntary organizations. Grants are provided as per guidelines only to such non-governmental organizations who are registered in the NGO Darpan portal of NITI Aayog, upon online application and due recommendation by district and state authorities.

The details of Non-Government Organizations working in the State of Andhra Pradesh & Gujarat which are receiving grants under the scheme of "Grant in Aid to Voluntary Organizations working for the welfare of STs" and funds released to them during last three years are given in **Annexure**.

- (d) & (e): No such incident has been reported for the scheme of "Grant in Aid to Voluntary Organizations working for the welfare of STs".
- **(f):** The Non-Governmental Organisations (NGOs) / Voluntary Organizations (VOs) funded under the scheme "Grant-in-Aid to Voluntary Organizations working for the welfare of Scheduled Tribes" are monitored as per the following schematic procedures:
 - 1. Annual inspection and recommendation by District Authority.
 - 2. Scrutiny and recommendation by State Government /UT Administration.

- 3. Mandatory submission of annual audited accounts and utilization certificate by NGOs/VOs.
- 4. Filing of expenditure by aided NGOs / VOs on PFMS using Receipt Expenditure Advance & Transfer (REAT) module.
- 5. Provision for Third-party monitoring by an independent agency.

Funds are only released to the NGOs for their projects after receiving the inter-alia inspection report of the district authorities indicating satisfactory performance and recommendation of the State Governments.
