### TARGET OF TWO CRORE AFFORDABLE HOUSES UNDER PMAY(U)

## NO. 55. DR. KANIMOZHI NVN SOMU:

#### Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) whether Government has fixed a target of constructing two crore affordable houses under Pradhan Mantri Awas Yojana Urban (PMAY-U);
- (b) if so, the details thereof;
- (c) whether Government has made any plan for the same;
- (d) if so, the details thereof along with the number of houses likely to be constructed, State-wise; and
- (e) the amount likely to be spent on this project and the manner in which it would be generated?

## ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) to (e) Ministry of Housing and Urban Affairs has been implementing Pradhan Mantri Awas Yojana-Urban (PMAY-U) under "Housing for All" Mission since June, 2015 to provide Central assistance to implementing agencies through States/ Union Territories (UTs) for providing all-weather pucca houses with basic civic services to all eligible urban beneficiaries through four verticals of PMAY-U, i.e. Beneficiary-led individual house construction/ enhancement (BLC), Affordable Housing in Partnership (AHP), 'In-situ' Slum Redevelopment (ISSR) and Credit Linked Subsidy Scheme (CLSS).

PMAY-U is a demand driven scheme and Government of India has not fixed any target for construction of houses. Based on the project proposals submitted by States/ UTs, as on 20.11.2023, 118.63 lakh houses have been sanctioned under PMAY-U, out of which 113.42 lakh have been grounded for construction; of which 78.15 lakh have been completed and delivered to beneficiaries. State/UT wise details of number of houses sanctioned since inception, Central assistance sanctioned, State share and Beneficiary share under PMAY-U are at Annexure.

Central assistance provided under the scheme year on year are through Budgetary allocation under PMAY-U.

The Ministry regularly reviews the status of implementation of PMAY-U with States/UTs through Monthly Progress Reports (MPRs), Monthly Review Meetings and in the meetings of Central Sanctioning and Monitoring Committee (CSMC).

The scheme period, which was earlier upto 31.03.2022, has since been extended upto 31.12.2024, except Credit Linked Subsidy Scheme (CLSS) vertical of the scheme, to complete all the houses sanctioned without changing the funding pattern and implementation methodology. Accordingly, States/UTs have been advised to expedite to complete all sanctioned houses within the extended Mission period as per Detailed Project Reports.
