NO. 59. SHRI NIRANJAN BISHI: SHRI SUJEET KUMAR:

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the data on target, number of houses sanctioned and houses completed under PMAY-U, State-wise;
- (b) whether there is a shortage in meeting the housing targets under the scheme in any State, including Odisha;
- (c) if so, the reasons therefor;
- (d) the reasons for the delay in releasing funds for PMAY-U in Odisha; and
- (e) the reason behind the decline in budgetary allocation for PMAY-U since 2021-22?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a) to (c): Ministry of Housing and Urban Affairs supplements the efforts of States/ Union Territories (UTs), by providing admissible Central Assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U), for construction of houses for all eligible families/ beneficiaries in urban areas since 25.06.2015. PMAY-U is a demand driven scheme and Government of India has not fixed any target for construction of houses under the scheme. Based on the demand for housing in the urban areas, States/UTs, including the State of Odisha, prepare project proposals and after approval of State Level Sanctioning and Monitoring Committee (SLSMC), these are submitted to the Ministry for sanctioning of admissible Central Assistance by Central Sanctioning and Monitoring Committee (CSMC). State/Union Territories (UT)-wise details of houses sanctioned, grounded and completed/delivered to the beneficiaries under PMAY-U as on 20.11.2023 are given at annexure.
- (d): Central Assistance under PMAY-U is released to States/ UTs in three instalments of 40%, 40% and 20%. The release of Central Assistance is incumbent upon fulfilment of mandatory compliances by the concerned States/ UTs viz. submission of Utilisation Certificates (UCs);

Aadhaar seeding of beneficiaries; Action Taken Report (ATR) on the recommendations of Third-Party Quality Monitoring Agencies (TPQMA), Geo-tagging of houses/projects, registration of Affordable Housing in Partnership (AHP)/ In-Situ Slum Redevelopment(ISSR) projects under Real Estate (Regulation and Development) Act, 2016 (RERA), etc. and other instructions issued by Ministry of Finance. Due installments are released to States/UTs on receipt of requisite compliances in respect of sanctioned projects under the scheme. Central Assistance of ₹ 3,176.98 crore has been sanctioned for the State of Odisha; out of which ₹ 2,350.27 crore has been released so far to the State based on the compliances achieved.

(e): The budgetary allocation for PMAY-U during FY 2021-22, FY 2022-23 and FY 2023-24 is as under:
