COVERAGE OF CROPS UNDER INSURANCE SCHEME

648 SHRI SANDEEP KUMAR PATHAK:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the details of crops covered under insurance scheme, State-wise;
- (b) the details of crops and number of farmers that were insured under the scheme in the last five years and those who applied for compensation after loss of their crops, number of farmers along with details of compensation amount paid to them, crop-wise, year-wise and State-wise; and
- (c) total premium paid to insurance companies during the said period and contribution of Central Government, State Governments and farmers for the same along with amount of money paid to farmers by insurance companies, details thereof, crop-wise, year-wise, State-wise and insurance company-wise?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE (SHRI NARENDRA SINGH TOMAR)

- (a): The Pradhan Mantri Fasal Bima Yojana (PMFBY) envisages coverage of all food crops (cereals, millets and pulses), oilseeds and commercial/horticultural crops subject to availability of past yield data of requisite number of years based on Crop Cutting Experiments (CCEs) as well as capacity of the State Government to conduct requisite number of CCEs to assess the yield of the crop to calculate claims. However, specific crop is notified by the concerned State Government keeping in view the aforesaid provision. For the crops not meeting the aforesaid conditions, the concerned State Government is free to notify them for coverage under Restructured Weather Based Crop Insurance Scheme (RWBCIS) under which claims payment are being structured on the basis of weather index parameters. Details of crops being notified by implementing States during Kharif and Rabi Seasons are given in **Annexure-I.**
- (b) & (c): The PMFBY is a demand driven scheme and is voluntary for the States as well as farmers. In fact, coverage under the scheme is increasing. The number of farmer applications has grown 33.4% and 41% year-on-year during 2021-22 and 2022-23, respectively. There is also a growth of 28.9% in farmers insured under the scheme in Kharif 2023 season (upto 30th November, 2023) as compared to Kharif 2022.

As per provisions of the scheme, actuarial/bidded premium rates are charged by insurance companies but the farmers have to pay maximum 2% for Kharif, 1.5% for Rabi food and oilseed crops and 5% for commercial/horticultural crops and the balance of actuarial/bidded premium is shared by the Central and State Government on 50: 50 basis and 90:10 in case of North Eastern States (from Kharif 2020 season) and Himalayan States (from Kharif 2023).

PMFBY is mainly implemented on 'Area Approach' basis and comprehensive risk coverage for crops of farmers against all non-preventable natural risks from pre-sowing to post-harvest stages of the crops at very minimum premium for the farmers is provided under the scheme. Admissible claims are worked out and paid directly to the insured farmer's account by the insurance companies/Digiclaim module based on the yield data, per unit area, furnished to the insurance company by the concerned State Government and claim calculation formula given below:

(Actual Yield – Threshold Yield) X Sum Insured Threshold Yield

However, losses due to localized risks of hailstorm, landslide, inundation, cloud burst & natural fire and post-harvest losses due to cyclone, cyclonic/unseasonal rains & hailstorms are calculated on individual insured farm basis. These claims are assessed by a joint committee comprising representatives of State Government and concerned insurance company. Therefore, reasons for crop damage under the scheme are not recorded.

For transparent calculation and settlement of claims by insurance companies, a claims management module namely "Digiclaim" has been developed w.e.f. Kharif 2022 season wherein all the claims are worked out through National Crop Insurance Portal (NCIP) and paid to farmers' accounts using Public Finance Management System (PFMS). This ensures full cycle monitoring of claims right upto the farmer level.

The selection of Insurance Companies is done by the State Governments through transparent bidding process wherein the L1 bidder is awarded the cluster. The roles and responsibilities of each stakeholder are defined in the operational guidelines of the scheme for the proper execution of the scheme.
