#### PM GATI SHAKTI SCHEME

#### 702. Shri R. Dharmar:

Will the Minister of **Commerce and Industry** be pleased to state:

- (a) the features of the PM Gati Shakti Scheme;
- (b) the details of the funds sanctioned, allocated and utilized under the scheme within the country so far;
- (c) the details of the number of projects covered under the scheme so far within the country, including Tamil Nadu;
- (d) the details of their present status;
- (e) whether Government has fixed any target under the scheme; and
- (f) if so, the details thereof?

#### **ANSWER**

### THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE & INDUSTRY (SHRI SOM PARKASH)

(a): PM GatiShakti (PMGS) National Master Plan (NMP), launched in October 2021, is a transformative approach for planning multimodal infrastructure connectivity to economic nodes in the country, for logistics efficiency with first and last mile connectivity. It is a GIS enabled platform that integrates more than 1400 data layers pertaining to infrastructure of roads, railway lines, ports, inland waterways, telecom lines, power lines, other social assets, land revenue maps, and natural resources etc onto a single portal and enables comprehensive planning for multimodal logistics. 39 individual portals for line Ministries and 36 States/UT portals have been developed and integrated.

To ensure better decision-making and coordination among various Central Ministries/Departments and State Governments, a three-tier institutional mechanism of Empowered Group of Secretaries (EGoS), Network Planning Group (NPG) and Technical Support Unit (TSU) is fully operational.

62 meetings of the NPG have taken place so far, to assess big infrastructure projects of Rs 500 Crore and above, on Gati Shakti NMP.

(b) to (f): No specific allocation of funds has been made under PMGatiShakti initiative. However, as part of Special Central Assistance Scheme - Part-II, 2022-23, Rs. 5000 Crores had been allocated for PM GatiShakti related expenditure to states, including State of Tamil Nadu.

The details of the funds allocated under the scheme along with the number of Projects in various States, including in the state of Tamil Nadu, is attached as **Annexure-I.** 

While there are no quantified targets under the initiative, PMGS is a visionary approach to planning of multimodal connectivity to economic, commercial and social clusters/zones. This is being implemented by various line Ministries, States and UTs, and is an ongoing process.
