PROCUREMENT OF RICE FROM FARMERS

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

(a) the data on the procurement of rice from famers for last 5 years, State-wise and yearwise;

(b) the amount given by Government for a kilo of rice and whether this amount is same in all States or different considering the conditions in each States;

(c) whether any State Governments are providing additional amount to farmers along with the amount given by Centre for the procurement; and

(d) the additional amount given by State Governments and the final amount being received by farmers for a kilo of rice; the details thereof, State-wise?

ANSWER

(a): The details of State wise, year wise rice procured for Central Pool during the last five years is at **Annexure-I**.

(b): The Minimum Support Price (MSP) is announced by the Government of India for the procurement of paddy every year before the sowing of the crop, which is uniform across the whole country. Government agencies along with FCI purchase food grains at MSP. The MSP announced for procurement of paddy during the last 03 years is below:

(c) & (d): Paddy is procured by the State Government or its agencies at MSP declared by the Government of India, from time to time. MSP amount and incidentals are reimbursed to the State Governments or its agencies as per the Cost Sheet approved by the Government of India. However, any financial assistance declared by the State Government above the MSP is borne by the State Government.
