Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state?

- (a) the details of imports and exports of polymers in the country from 2019, country wise;
- (b) the steps taken by the Government to encourage domestic production, including its growth; and
- (c) the reasons as to why there is no import duty on polymers despite requests from the domestic plastic Industry?

ANSWER

THE MINISTER OF STATE CHEMICALS & FERTILIZERS
(SHRI. BHAGWANTH KHUBA)

- (a) The country- wise details of import & export of polymers, since 2019 is attached herewith(**Annexure-I**: Import & **Annexure-II**: Export).
- (b) Government has taken various steps to encourage domestic production such as:
 - i. **Petroleum, Chemicals and Petrochemicals Investment Regions (PCPIRS)** –The PCPIR Policy aims to boost manufacturing in the chemicals and petrochemicals sector, augment exports and generate employment with co-development of downstream industry through a cluster-based approach. So far, four PCPIRs have been notified in Gujarat (Dahej), Andhra Pradesh (Vishakhapatnam), Odisha (Paradeep) and Tamil Nadu (Cuddalore and Nagapattinam), and these are at different levels of implementation.
 - ii. **Central Institute of Petrochemicals Engineering and Technology (CIPET)** has been conducting regular long-term Diploma & Degree programmes with emphasis on practical training in the field of plastics engineering and technology, with the objective of creating a pool of skilled manpower required in the sector.
 - iii. **Enforcement of international quality norms and compliances-** With the objective to curb the import of sub-standard products and to improve the quality of chemicals and petrochemicals products produced in the country, standards of Chemicals/ Petrochemicals have been made mandatory to ensure that importers as well as domestic manufacturers fulfil the BIS quality parameters. 28 QCOs have been issued in the sector and out of these 14 OCOs have been implemented (List enclosed as **Annexure-III**).
 - iv. To support domestic industry and make it more competitive in the international market, Government has notified **Remission of Duties and Taxes on Exported Products (RoDTEP)** Scheme vide notification dated 17.08.2021 for various sectors including plastic polymers.

(c) The import of polymer is not duty free. The duties on polymers are as under:
