SILK SAMAGRA SCHEME IN ODISHA

***15. DR. SASMIT PATRA:**

Will the Minister of TEXTILES be pleased to state:

- (a) the details of benefits under the various components of the Silk Samagra scheme since 2021 for the State of Odisha, year-wise;
- (b) the details of funds allocated and utilized since 2021 for the State of Odisha, year-wise;
- (c) whether Government is considering the promotion of cluster-based sericulture industries in the State of Odisha under the scheme, and if so, the details thereof; and
- (d) whether Government is planning to facilitate and fund the establishment of large industrial silk spinning units for entrepreneurs in the State of Odisha under the scheme, and if so, the details thereof?

(a): The details of benefits year-wise and component-wise details of financial assistance/benefits provided to Odisha state under Silk Samagra-2 scheme towards beneficiary components since 2021-22 are given in the **Annexure-I**

(b): The year-wise details of funds allocated/released to Odisha and utilized by the state under Silk Samagra-2 since the year 2021-22 are as follows:

(c): Under the Silk Samagra 2 scheme, there is a provision under its beneficiary components to support small and marginal farmers/stakeholders of silk sector including the components covering eri silkworm rearing to eri silk spinning activities in cluster mode. Under this provision, the state sericulture departments including that of Odisha shall implement the beneficiary components in cluster mode with not less than 50 beneficiaries in each block, by submitting proposal in compliance to scheme guidelines.

(d): Under beneficiary oriented component of Silk Samagra-2 scheme, assistance is provided for establishment of silk reeling units like Automatic Reeling unit, Twisting unit, Multi-end reeling unit etc. and also Miniature Eri spinning plant for new/existing entrepreneurs.
