(a) and (d) Details of State-wise utilisation of funds released under Nirbhaya framework for safety of Women on Public Transport are provided in Annexure-1. The funds released under Nirbhaya Framework to States/UTs are based on the number of vehicles and the geographical area for determination of maximum project cost.

(b) and (c) As per Scheme Guidelines, periodic (quarterly) progress review of implementation of the Scheme across various States/UTs is undertaken. Detailed audit of the projects under Nirbhaya framework was also conducted during the period of July 2022 to September 2022. Periodic reviews are also done by the Empowered Committee set up under the Ministry of Women and Child Development.
