- (a) whether the Government has taken any steps for rejuvenation of religious sites for boosting tourism in the country;
- (b) if so, the details thereof; and
- (c) projected boost in religious tourism due to the construction of the Ram Mandir in Ayodhya?

(a) to (c): A Statement is laid on the Table of the House.

STATEMENT IN REPLY TO PARTS (a) To (c) OF RAJYA SABHA STARRED QUESTION NO.65 ANSWERED ON 08.02.2024 REGARDING REJUVENATION OF RELIGIOUS SITES BY SHRI, PABITRA MERGHERITA.

(a) to (b): The Ministry of Tourism (MoT) launched the 'National Mission on Pilgrimage Rejuvenation and Spiritual Augmentation Drive (PRASAD)' Scheme in 2015 for the development of tourism infrastructure and tourist amenities at identified pilgrimage destinations in the country. The nomenclature of the scheme has been changed from PRASAD to "National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD)" in October 2017. A total of 46 projects have been sanctioned for an amount of Rs.1631.93 Crore and 27 new sites has been identified for development under the PRASHAD Scheme.

The Ministry also launched 'Swadesh Darshan' Scheme in 2015 for the development of theme-based tourist circuits in the country. Under the Swadesh Darshan Scheme, 15 themes were identified for development of tourist circuits. Projects have been sanctioned under the Buddhist Circuit, Krishna Circuit, Ramayana Circuit, Spiritual Circuit & Tirthankar Circuit to cater to the development of tourism infrastructure at religious/spiritual tourism destinations. A total of 23 projects have been sanctioned for an amount of Rs.1375.43 Crore under the above-mentioned themes of the Swadesh Darshan Scheme. Additionally, 57 new destinations, including religious/spiritual destinations, have been identified for development under the Swadesh Darshan 2.0.

The components taken up for development under the above scheme includes basic amenities/facilities such as Pilgrim Facilitation Centres (PFCs), Food Courts/Cafeteria/Prashadam Counters, Parking, Illumination, Queue Management complexes, Interpretation Centres, Toilet Blocks, Parking facilities, Water/Sewage Treatment Plants, Solid Waste Management, etc. The details of projects sanctioned, and sites/destinations identified for development under PRASHAD and Swadesh Darshan scheme are annexed.

In addition to the development of tourism infrastructure, MoT has also been promoting religious tourism. MoT has launched UTSAV portal which has details of over 1200 events and festivals and more than 50 live Darshans. The Incredible India website of Ministry of Tourism has details on religious sites and destinations in the country for promoting religious tourism.

(c): The Ministry had sanctioned the project 'Development of Ayodhya' under the Swadesh Darshan Scheme in 2016-17, with a budget of Rs.127.21 Crore. The major components developed under the project includes Development of parking at Ram Katha Gallery, development works at Ayodhya Bus Stand, façade illumination at Ram ki Paidi, Ghat and parking development at Guptar Ghat, Ghat development at Laxman Kila Ghat, solar lighting, gazebos and street lighting in Ayodhya city, Tourist shelter at Panchkoshi Parikrama etc. As per the information received from the State Government of Uttar Pradesh, 27.80 lakh visitors have visited the Ram Mandir in Ayodhya from the day of Pran Pratishtha upto 05.02.2024.
