### STATEMENT REFERRED IN REPLY TO PARTS (a) to (d) OF RAJYA SABHA STARRED QUESTION NO. 71 DUE FOR 08.02.2024

- (a) and (b) Ministry of Culture administers various Central Sector Schemes under which financial assistance is provided directly to eligible cultural organizations / individuals working in the field of art and culture across the country including the State of Madhya Pradesh. There are no provisions for state-wise allocation of funds under these schemes. The release of financial assistance under these schemes depends upon the receipt of complete proposals from cultural organizations / individuals from the states/UTs. The details of financial assistance released to various cultural organizations/individuals in the state of Madhya Pradesh under various schemes during 2021-22 to 2023-24 and 2020-21 are given at Annexure. From the data given at Annexure, it is evident that there is continuous increase in the total financial assistance released to cultural organizations / individuals under various schemes in the state of Madhya Pradesh.
- (c) and (d) As stated above, various Central Sector Schemes are being administered by Ministry of Culture for promotion of art and culture across the country including the state of Kerala. However, no special scheme for Kerala has been approved by the Ministry of Culture during 2021 2024.
