AFFORDABLE AIR TRAVEL FOR PASSENGERS FROM JHARKHAND

171. SHRI ADITYA PRASAD

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) whether Government is considering to make air travel more affordable for the people of Jharkhand State;
- (b) if so, the details thereof and if not, the reason therefor; and
- (c) the year-wise data of domestic air passenger traffic since 2019 along with the details thereof, State-wise including Jharkhand?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a) & (b): The Government launched the Regional Connectivity Scheme (RCS) - UDAN (Ude Desh ka Aam Nagrik) in October 2016 to enhance regional air connectivity from unserved and underserved airports in the country for making air travel affordable to the people of India including the State of Jharkhand. Promoting affordability of regional air connectivity is envisioned under UDAN by supporting Selected Airline Operators (SAOs) through concessions by the Central Government, State Governments/UTs and airport operators to reduce the cost of operations on regional routes and providing financial (Viability Gap Funding or VGF) support to meet the gap.

In the state of Jharkhand, 6 (six) airports, Bokaro, Dumka, Jamshedpur, Hazaribagh, Deoghar and Daltonganj have been identified for development and operation of RCS flights.

Jamshedpur and Deoghar Airports have been operationalised and Licensing is in progress at Bokaro and Dumka. Hazaribagh and Daltonganj are yet to be taken up for development due to land and other issues.

8 Routes have been operationalised in the State of Jharkhand under the UDAN scheme.
