Will the Minister of CIVIL AVIATION be pleased to state:-

(a) the number of aircrafts with different airlines as on date and order placed for number of aircrafts by different airlines;

(b) the number of commercial pilot license issued in last three years, and the number of women pilots issued license in last three years; and(c) the number of aircrafts lying idle at different airports, airline-wise idle aircrafts, and reason for them remaining idle?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a): The number of aircraft endorsed on Air Operator Certificate (AOC) with different airlines as on 31.12.2023 is at Annexure-I. The details about the number of aircraft orders placed by major airlines are at Annexure-II.

(b): The number of commercial pilot licenses issued in last three years is 3649 out of which the number of licenses issued to women pilots is 972.

(c): No centralised data about the aircraft lying idle at different airports is maintained. An aircraft may remain idle/grounded for

several reasons such as repairs being uneconomical, non-availability of spare parts, expiry of lease validity etc.
