- (a) the details of operational clusters under the Scheme of Fund for Regeneration of Traditional Industries (SFURTI), State-wise;
- (b) the details of the projects completed under the SFURTI scheme since its inception, State-wise;
- (c) the number of beneficiaries under the SFURTI scheme and the assistance provided to its beneficiaries in Andhra Pradesh; and
- (d) whether Government has conducted any study to assess the improvement in incomes of the beneficiaries due to SFURTI, if so, the details thereof?

- (a) & (b): The State wise status of clusters approved under SFURTI is annexed at Annexure-I.
- (c): As on date, 16 clusters have been approved in the state of Andhra Pradesh with GoI Assistance of around Rs. 4402.5 lakh, benefitting around 13,498 artisans.
- (d): Yes Sir. An evaluation study was conducted by Development Monitoring and Evaluation Office (DMEO), NITI Aayog wherein an increase of 83% was noted in pre and post intervention income of the artisans in the studied clusters.
