# EXPENDITURE UNDER CSR QUESTION

#### 354. Shri Biplab Kumar Deb:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the amount spent by various industrial units in the State of Tripura under Corporate Social Responsibility (CSR) during the last five years; and
- (b) the details of the amount spent, district-wise and area-wise?

#### **ANSWER**

(a) & (b): The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. Section 135 of the Act mandates every company having net worth of Rs. 500 crore or more, or turnover of Rs. 1000 crore or more, or net profit of Rs. 5 crore or more during the immediately preceding financial year, to spend at least two per cent of the average net profits of the company made over immediately preceding three financial years towards CSR as per the CSR Policy of the Company. The CSR framework is disclosure based and companies are required to file details of CSR activities annually in the MCA21 registry. On the basis of annual filings made by Companies in the MCA21 registry, the district-wise and sector-wise details of CSR spent by various companies in the State of Tripura during the last five financial years (FYs) 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22 are at Annexure – I and Annexure-II respectively.
