ASSISTANCE TO STATES FOR CAPITAL EXPENDITURE

Will the Minister of FINANCE be pleased to state:

- (a) the details of the amount of Special Assistance provided as loan to States for capital expenditure, State-wise and project-wise in the year 2023; and
- (b) the amount of Special Assistance provided for capital expenditure and for externally aided projects to the State of Bihar since 2019?

ANSWER

THE MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

(a): The 'Scheme for Special Assistance to States for Capital Investment 2023-24' has eight Parts. The scheme guidelines, inter-alia, include an amount of Rs. 1 lakh crore under Part-I (untied) of the Scheme which has been allocated to States in proportion to their share of Central Taxes as per the award of the 15th Finance Commission (FC) and incentive amounts of Rs. 35,000 crore earmarked for seven reform centric and sector specific areas, viz, Part-II (scrapping of old vehicles), Part-III (urban planning reforms), Part-IV (financing reforms in urban local bodies to make them creditworthy for municipal bonds), Part-V (housing for police personnel above or as part of police stations), Part-VI (unity malls), Part-VII (children and adolescents' libraries and digital infrastructure) and Part-VIII (incentive for implementing "Just in Time" release of CSS funds). The State-wise and Part-wise details of Special Assistance (Loan) provided to the States during the financial year 2023-24 (as on 01.02.2024) is provided in Annexure.

(b): The details of the amount of Special Assistance (Loan) provided under the Schemes for Special Assistance to States for Capital Expenditure/Investment and for externally aided projects to the State of Bihar since 2019 are provided in the Table below:
