STATUS OF AB-PMJAY

423. DR. SASMIT PATRA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of funds allocated and utilized towards the treatment of beneficiaries under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) since the inception of the program, State-wise and year-wise;
- (b) the insurance claimed and collected by the hospitals or healthcare institutions under this program since its inception, State-wise and year-wise;
- (c) the details of beneficiaries registered and benefiting from this program since its inception to date, State-wise and month-wise;
- (d) whether Government has received any concerns or identified any irregularities in this program, and if so, the details thereof; and
- (e) the measures taken by Government to improve its scope and reach?

(a) to (e): The details of budget allocated and funds utilized under Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) are as under:

Under AB-PMJAY, central share of funds is released to the States/UTs on the basis of actual utilization of the scheme by the beneficiaries, subject to a ceiling. There is no State specific allocation under the scheme. State/UT-wise and Financial year-wise details of funds released under the scheme are at **Annexure-I**.

As of 15.01.2024, approximately 6.22 crore hospital admissions worth Rs. 79,174 crore have been authorized under the scheme. Approximately 6.19 crore claims have been submitted by the empanelled hospitals for the treatment provided under the scheme, out of which 5.78 crore claims have been settled. State/UT-wise and Financial year-wise details of claims submitted and claims settled under the scheme are at **Annexure-II**.

AB-PMJAY is an entitlement-based scheme and therefore, beneficiaries are not required to register. All the eligible beneficiary families are covered from day one of the implementation of the scheme in the States/UTs. However, a beneficiary verification process is undertaken to verify the identity of the beneficiary. Further, verified beneficiaries are issued Ayushman Card, as a token of entitlement and empowerment. Eligible beneficiaries cannot be denied treatment in the absence of an Ayushman Card.

As on 29.01.2024, over 30.8 crore Ayushman Cards have been created across the country. Six States are using their own IT platform for scheme implementation, and therefore, month-wise data is not available for all States. State/UT-wise and Financial year-wise details of Ayushman cards created under the scheme are at **Annexure-III**. State/UT-wise and Financial year-wise details of authorized hospital admissions under the scheme are at **Annexure-IV**.

The Comptroller and Auditor General (C&AG) audit report on Ayushman Bharat -Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) was tabled in the Parliament on 8th August 2023 (<https://cag.gov.in/en/audit-report/>). National Health Authority (NHA) has submitted its Action Taken Note (ATN) to C&AG observations. The ATN includes NHA's clarifications regarding audit observations and details of action taken wherever applicable.

About 45,000- 50,000 hospital admissions are authorized under the scheme every day. Massive Ayushman card creation drive and IEC campaigns across the country are undertaken. The details of different initiatives taken in this direction under the scheme are at **Annexure-V**.

The details of different initiatives taken in this direction under the scheme:

- Ayushman card creation Drive: After massive success of Aapke Dwar Ayushman (ADA) campaign 1.0 and 2.0 with the creation of approximately 10 crore Ayushman cards created during 2022-23 only, ADA 3.0 campaign has been launched with Self-verification feature enabling beneficiaries to create Ayushman card for himself/herself along with his/her family. Also, 'Ayushman Bhava' campaign has been launched by Hon'ble President of India on 13.09.2023 across the country with the mission to saturate Ayushman card creation in the country. Ayushman card creation is one of the on-spot services being offered under 'Viksit Bharat Sankalp Yatra' (VBSY). More than 2.78 crore Ayushman cards have been created during VBSY.
- Technology upgradation – The newly launched BIS 2.0 platform makes it convenient for scheme's beneficiaries to generate Ayushman cards. Under BIS 2.0, village wise access to beneficiary database has been enabled for better mobilization of the scheme's beneficiaries. "Ayushman App" has been launched for Ayushman Card creation. The app has a unique feature of self-verification. In simple four steps, this feature enables users to create Ayushman Card using a mobile phone.
- A comprehensive media and outreach strategy to spread awareness and to empower the beneficiaries about their entitlements and rights under the scheme has been followed. This includes the use of media vehicles such as outdoor media, digital display at ticket counters across various railway stations, announcements at major bus stations, passenger train branding, national and regional press coverage, op-eds and advertorials in print media, radio campaign, telecast of beneficiary testimonials via Doordarshan, mass messaging through SMS, traditional media etc.
- Support of ASHA workers, frontline workers under Panchayati Raj, Self Help Groups under the National Rural Livelihood Mission (NRLM) for beneficiary mobilization, e-KYC for card creation and IEC related activities is sought.
