SKILL INDIA PROGRAMME

602. Dr. M. Thambidurai:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the details and the salient features of Skill India Programme;
- (b) whether this training programme leads the youths to employability;
- (c) if so, the details thereof; and
- (d) the details of the youths who got training during the last four years, year-wise, State-wise, along with the details of those who got employed during the said period, State-wise?

ANSWER

(a to c) Under the Government of India's Skill India Mission (SIM) , the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through an extensive network of skill development centres/colleges/ institutes etc. under various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country. The SIM aims at enabling youth of India to get future ready, equipped with industry relevant skills. The brief of these schemes is as under:

Pradhan Mantri Kaushal Vikas Yojana (PMKVY): PMKVY Scheme is for imparting skill development training through Short-Term Training (STT) and up-skilling and re-skilling through Recognition of Prior Learning (RPL) to youth across the country including rural areas.

Jan Shikshan Sansthan (JSS) Scheme: The main target of the JSS is to impart vocational skills to the non-literates, neo-literates and the persons having rudimentary level of education and school dropouts upto 12th standard in the age group of 15-45 years, with due age relaxation in case of "Divyangjan" and other deserving cases. Priority is given to Women, SC, ST, OBC and Minorities in the rural areas and urban low-income areas.

National Apprenticeship Promotion Scheme (NAPS): This Scheme is for promoting apprenticeship training and increasing the engagement of apprentices by providing financial support for payment of stipend to apprentices. Training consists of Basic Training and On-the-Job Training / Practical Training at workplace in the industry.

Craftsmen Training Scheme (CTS): This scheme is for providing long-term training through Industrial Training Institutes (ITIs) across the country. The ITIs offer a range of vocational/skill training courses

covering a large number of economic sectors with an objective to provide skilled workforce to the industry as well as self employment of youth.

(d) The State-wise and Year-wise number of candidates trained under Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Shikshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) during the last four year 2019-20 to 2022-23 is placed at **Annexure-I, Annexure-II, Annexure-III, Annexure-IV** respectively.

Among the schemes of the MSDE, placement is specifically tracked only under Short Term Training (STT) component of PMKVY. The State-wise and year-wise number of candidates reported placed during the last four year 2019-20 to 2022-23 under STT component of PMKVY is placed at **Annexure-V**. As regards other schemes, third party evaluation reports have observed success in terms of placement or enhancement of income of candidates trained. As far as employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident. The report has further observed that usefulness of the scheme would be further evident from the fact that 77.05% of the beneficiary trainees have undergone occupational shifts. The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, GoI) mentions that 63.5% of total ITI pass-outs got employed (wage + self, out of which 6.7% are self- employed).
